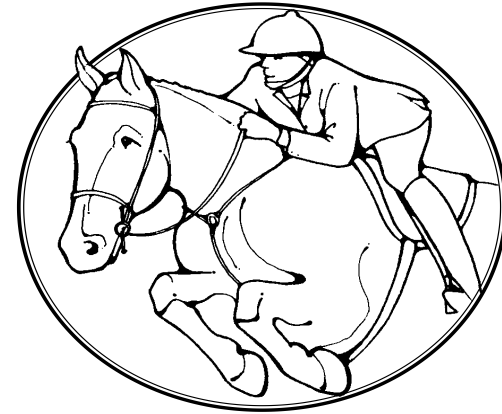

If you are not a member and/or have any questions concerning this prize list or specifications of any division, please phone Winter Glen Farm at (518) 356-3364.
2. The management reserves the right to decline any entry and to return entrance fees without being held for compensation.
3. Winter Glen Farm, the CDHJC and the TCRA will not be liable whatsoever for any injury or damage to any person or property of any spectator, visitor, exhibitor, attendant, or any other persons by reason of an event at the show; it shall be a condition of entry that each person holds Winter Glen Farm, the CDHJC and the TCRA harmless for any accidents which occur by reason of fire or otherwise.
4. Post entries will be accepted.
5. Protective headgear must be worn while on any horse or pony on the show grounds.
6. Management reserves the right to cancel any event that has less than 4 entries.
7. Management reserves the right to combine divisions.
8. Management reserves the right to divide classes into multiple classes.
9. All entry blanks must be properly completed and signed by the rider (parent if rider under 18), owner and trainer before a number will be issued. NO EXCEPTIONS
10. A \$30.00 fee will be charges for all returned checks.
11. Limited permanent stalls with door available - \$30.00 per stall.
12. Insurance fee - \$10.00 per entry.
13. Schooling in the outside ring until the start of the Beginner Cross Rails.

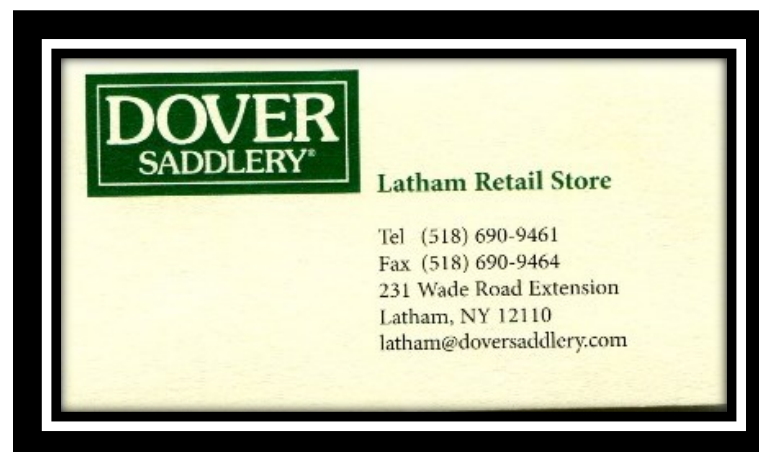
